88 of the 1,440 people in this report have record with major inconsistencies. This indicates some of the problems found in genealogy research. Some of the errors are obtained because some the dates are not correct. Some or the errors are obtained because of ambiguity in the data available. Other errors are introduced when researchers have good data and make bad decisions. My genealogy report is based largely on the research of others, hence it is compromised with the errors of others. I have removed some of the most absurd inconsistencies, but many inconsistencies still exist. In any case, the report would not be complete without full disclosure of apparent problems:
